You are invited to take part in this research project, which aims to explore and define current and potential roles of patients in interprofessional collaborative practice in primary care to effectively manage complex and/or long-term medical conditions. This phase will explore health professionals' experiences of patient involvement in team care.

What is the purpose of this research?

Explore how health professionals' experience the provision of care and involvement of their patients with complex and long-term medical conditions in interprofessional collaborative practice in primary care. We are interested in hearing about your professional opinion and experiences in this field. The outcome of this study is to develop a framework to inform collaborative practice and interprofessional education.

Why have I been invited to participate?

You have been invited to participate because you are a health professional who currently works in the primary health care setting in Australia and have influence on collaborative practice.

What does participation in this research involve?

You will be invited to an interview with Alexandra Davidson, either in person, over the telephone or videoconference, whichever is most convenient for you. If Government regulations are in place to limit to essential travel only, then we will discuss using technology, telephone or videoconference for your interview.

The interview will last for about 30 minutes to one hour. This interview will be audio recorded, and the transcripts will be used in data analysis. Questions in this interview will be about your professional opinions and experiences in this field.

Participation in this research project is voluntary. If you decide to take part and later change your mind, you are free to withdraw from the project at any stage, without any reason.



What are the possible benefits of taking part?

What are the possible risks and disadvantages of taking part?
